

**SPECIAL BUSINESS TERMS - CORPORATE RISK MANAGEMENT AND SECURITY CONSULTING No. CRM01  
regulating provision of services of corporate risk management and security consulting by SECURITAS ČR s.r.o.**

**1 SUBJECT, SCOPE, SERVICE FEE AND SITE**

- 1.1 The Special business terms Corporate risk management and security consulting (SBT) specify in detail the terms and conditions for providing services of corporate risk management and security consulting upon the agreement (hereinafter the "Agreement") entered into between the service provider, the corporation SECURITAS ČR s.r.o., with its registered office at Pod Pekárnami 878/2, Praha 9, Vysočany, Postcode 190 00, Business Id. No 43872026, entered in the Commercial Register kept by the Municipal Court in Prague, Section C, File 5009, or its subsidiary (hereinafter "SECURITAS"), and the Customer.
- 1.2 These SBT are business terms in compliance with Section 1751 (1) of the Civil Code (Act No. 89/2012 Coll.). The SBT wording supersedes the wording of the General business terms SECURITAS (GTC).
- 1.3 The scope of the Services, the service fee and if applicable, the Site(-s) at which the Services are to be performed, are specified in the Agreement and its Appendices.

**2 SECURITAS' RESPONSIBILITIES**

- 2.1 Securitas will carry out the Services in accordance with the Service description set out in the Agreement and its Appendices.
- 2.2 Securitas will carry out the Services with personnel who are suitably qualified and skilled.

**3 CUSTOMER'S RESPONSIBILITIES**

- 3.1 The Customer shall provide Securitas with any information which Securitas reasonably require to enable Securitas to carry out the Services.
- 3.2 If required in order for Securitas to carry out the Services, the Customer shall afford Securitas authorised personnel full and safe access to the Site or any other property or area at which the Services are to be carried out.
- 3.3 The Customer is responsible for any site specific requirements and training at its own expense. Securitas is entitled to charge the Customer for participation by Securitas' personnel in training courses and any safety screenings.

**4 FEE ESTIMATE**

- 4.1 Unless otherwise agreed, any total fee provided for the Services is an estimate of Securitas' fees to carry out the Services and Securitas shall be entitled to charge the Customer for all work carried out in the performance of the Services.

**5 OWNERSHIP OF RESULTS**

- 5.1 Securitas shall be the exclusive owner of all results of the work performed by Securitas in the performance of the Services, unless otherwise agreed in writing with the Customer. The Customer is granted a non-exclusive licence to use reports and other materials delivered to the Customer for internal use only.

**6 WARRANTY AND LIABILITY**

- 6.1 Securitas warrants that the Services will be carried out with reasonable skill and care. Securitas provides no other warranty with respect to the Services.
- 6.2 In the event of a breach of the warranty above, Securitas shall at its own cost re-perform such part of the Services which do not conform to the warranty. If re-performance is not practicably possible, Securitas shall offer the Customer a reduction of the fees paid by the Customer for such part of the Services which do not conform to the warranty. The remedies set out above shall be the Customer's sole and exclusive remedy for breach of warranty.
- 6.3 The Customer shall notify Securitas of any warranty claim arising from the Services in reasonable detail and in writing within thirty (30) days from the date on which the Customer became aware (or should reasonably have become aware) of the occurrence giving rise to the claim. If the Customer does not provide such notice to Securitas within six (6) months from the occurrence, Securitas shall have no obligation to re-perform the Services or make any payment whatsoever relating to such claim.
- 6.4 Securitas annual maximum liability to the Customer under this Agreement shall not exceed CZK 1,000,000.

**7 EFFECTIVENESS OF THE SPECIAL BUSINESS TERMS**

- 7.1 These SBT come into force and effectiveness on 1 May 2017.
